



# AQH Examination Schedule, Fees & Terms

## Advanced Qualification In Headache Medicine Certificate (AQH) Spring 2026 Examination Policies

The AQH examination is a proctored computer-based exam available either in person at a test center, or online using a computer at a location of your choice.

- **Ideal for Online Option at your location: Personal computer, Hard-wire connectivity.**

Applicants must submit a complete online application and pay the full administrative and examination fees to be considered for candidacy to sit for the AQH certification exam.

- All applications are reviewed by the AQH Committee.
- Your acceptance depends on eligibility, and completion of application requirements.

### Definitions

- **Applicant**-Any individual who applies to be considered for eligibility to sit for the AQH examination.
- **Candidate**- Any individual accepted as eligible to sit for the AQH examination and register for the examination.

### February 16 – March 20, 2026:

- Application period, receipt of required information, payment of \$875.00 fees up-front.
- For an application to be reviewed, a finalized application and full payment must be received together. NHF only accepts American Express, Visa, MasterCard and Discover.

### March 21 – March 27, 2026:

- Late application special exception-additional \$150.00 late application fee up-front with application and examination fee of \$875.00.

### March 27, 2026:

- No applications will be accepted if received after this date for the Spring 2026 examination.

### March 30 – April 17, 2026:

- Approved candidates will receive examination registration instructions included with their notification email.
  - **Online Testing Candidates must run a "system check" before April 10, 2026. If your system doesn't meet the requirements you will need to transfer to a test center. There is no fee for the transfer if requested before April 10. Transfers requested April 10 – 20, 2026 will incur a \$125 transfer fee. (See the "Location Selection Guide" for details on how to run the "system check".). No changes allowed after April 20, 2026, or during testing period May 4 - May 22, 2026.**

### May 4 – May 22, 2026:

- Examination testing window open, with test results communicated in June 2026.

### Application Review and Approval

All applications are reviewed to ensure the application is complete and the applicant meets all eligibility requirements. The AQH team will contact the applicant to correct any areas of deficiency. All applicants will receive an email notification confirming their application approval or denial. Candidates who are approved will receive examination registration instructions included with their notification email.

<u>Rescheduling Fee</u> <ul style="list-style-type: none"> <li>• Before 72 hours of the currently scheduled exam/test appointment, within current exam/test period</li> </ul>	\$ 0.00 (online)	Applies to candidate moving test appointment at least 72 hours before their scheduled exam/test and are <b>able to reschedule within the same exam testing period.</b> <ul style="list-style-type: none"> <li>• Note: Not moving to next exam/test period.</li> <li>• Must use the online rescheduling link provided.</li> </ul>
<u>Rescheduling Fee*</u> <ul style="list-style-type: none"> <li>• Less than 72 hours before the currently scheduled exam/test appointment to next exam/test period</li> </ul>	\$500.00	Candidates providing less than 72 hours notification will <b>forfeit</b> the \$500.00 initial exam fee. There will be a new \$500.00 examination fee assessed to move to the next exam testing period.
<u>Rescheduling Fee*</u> <ul style="list-style-type: none"> <li>• Before 7 business days of the currently scheduled exam/test appointment to next exam/test period</li> </ul>	\$125.00	Applies to candidates <b>moving test appointment to the next exam testing period.</b> <ul style="list-style-type: none"> <li>• Non-refundable.</li> </ul>
<u>Transfer Test to Different Method or Location Fee*</u> <ul style="list-style-type: none"> <li>• Before April 10, 2026 (1)</li> <li>• April 10 - 20, 2026. (2)</li> </ul>	(1) \$0.00 (2) \$125.00	Moving exam from Test Center to Online OR Online to Test Center must be completed before April 21, 2026 or may need to transfer to next testing period, if option not available during current testing window. (\$125.00 is non-refundable) <ul style="list-style-type: none"> <li>• <b>Can only transfer once within same exam testing period.</b></li> </ul>
<u>Transfer to Next Examination Testing Period Fee*</u> <ul style="list-style-type: none"> <li>• Before 7 business days of the currently scheduled exam/test appointment</li> </ul>	\$125.00	Moving application and examination to <b>next exam testing period.</b> <ul style="list-style-type: none"> <li>• Maximum transfer - two times within one year - to one of next AQH testing periods-\$125.00 for each transfer (non-refundable)</li> <li>• Beyond two times, forfeit the \$500.00, reapply for \$875.00.</li> </ul>

<u>Emergency Fee*</u> <ul style="list-style-type: none"> <li>Less than 7 days before the currently scheduled exam/test appointment</li> </ul>	\$250.00	Must provide documentation regarding the emergency. <ul style="list-style-type: none"> <li>Documentation evaluated by the AQH team.</li> <li>Candidate <b>must transfer to the next exam period.</b></li> <li>Non-refundable.</li> </ul>
<u>Online Proctoring Issue Fee*</u> <ul style="list-style-type: none"> <li>During testing, unable to continue with examination/stopped</li> </ul>	\$350.00	Exam stopped, unable to complete, and can <b>reschedule</b> within the same exam test period if days/times available. <ul style="list-style-type: none"> <li>\$350.00 is the required Additional Fee, Non-refundable.</li> </ul>
<u>Online Proctoring Issue Fee*</u> <ul style="list-style-type: none"> <li>During testing, unable to continue with examination/stopped</li> </ul>	\$500.00	Exam stopped, unable to complete, no remaining days/times in same exam period available, so required to move to next exam period. You forfeit the initial \$500.00 exam fee. <ul style="list-style-type: none"> <li>Must pay new \$500.00 exam fee.</li> <li>Non-refundable.</li> </ul>
<u>Re-Examination Fee*</u> <ul style="list-style-type: none"> <li>Must sit for exam again in one of the next two sessions/test windows</li> </ul>	\$500.00	For those who forfeited the exam fee who: <ol style="list-style-type: none"> <li>Previously attempted and failed the examination.</li> <li>Did not reschedule or transfer within the allowed 72 hour time period.</li> <li>No show on scheduled day/time.</li> </ol>
<u>Re-Examination Fee*</u> <ul style="list-style-type: none"> <li>Must sit for exam again, greater than two sessions/test windows from initial examination.</li> </ul>	\$375.00 and \$500.00	For those who forfeited the exam fee who: <ol style="list-style-type: none"> <li>Previously attempted and failed the examination.</li> <li>Did not reschedule or transfer within the allowed 72 hour time period.</li> <li>No show on scheduled day/time.</li> <li>\$375.00 application fee is non-refundable.</li> </ol>
<u>Appeals Fees*</u>	\$100.00 to \$250.00	Depends on the type of appeal (non-refundable): <ol style="list-style-type: none"> <li>Appeal - Application Denial (\$100.00)</li> <li>Appeal - Administration Issues (\$100.00)</li> <li>Appeal - Certification revoked (\$250.00)</li> </ol>
